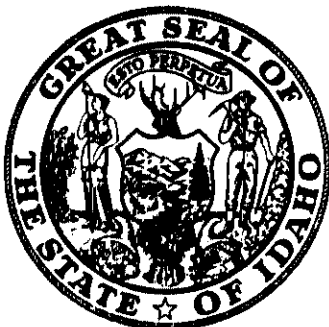
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
AMOTH TRUCKING, INC.

ARTICLE I.

The name of the Corporation shall be Amoth Trucking, Inc..

ARTICLE II.

The period of duration shall be perpetual.

ARTICLE III.

The purposes for which the Corporation is organized shall be conducting the business of commercial short-haul and long-haul trucking, and shall include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE IV.

The aggregate number of shares of which the Corporation shall have authority to issue shall be five hundred thousand (500,000) shares of common stock, the par value of which shall be no par.
