KNOW ALL MEN BY THESE PRESENTS:

That a two-thirds vote of the members and in accordance with and pursuant to Idaho Code 30-301 and the Idaho Nonprofit Corporation Act, do hereby Amend the Articles of this Corporation and adopt the following as the Articles of Incorporation.

ARTICLE I. CORPORATE NAME

The name of the Corporation is Gem Community Citizen's Projects Group Inc. dba Hayden Senior Center, Inc.

ARTICLE II. OBJECTIVES

To facilitate improvement, goodwill and quality of life for individuals, groups and organizations in the local communities.

ARTICLE III. GENERAL MEMBERSHIP

(1) All persons eighteen years of age or older who have signed a statement that they agree and support the purposes for which this Corporation exists shall be members of the Corporation.

(2) The Corporation, may as a condition of membership, impose a membership fee as shall be set forth in the corporate Bylaws.

(3) Pursuant to Idaho Code 30-308(e) the members shall not be personally liable for the debts, liabilities or obligations of the Corporation.

(4) Fifteen members of the General Membership may upon giving notice to the Executive Director and the President have a special meeting of the members for such purposes as set forth in the notice given for such meeting.

ARTICLE IV. DIRECTORS

There shall be a minimum of seven and a maximum of fifteen Directors whose terms shall be set forth in the Bylaws. Any vacancy may be filled at the discretion of the remaining Directors.

ARTICLE V. OFFICERS

There shall be a minimum of four Officers consisting of a President, Vice-President, Secretary and Treasurer as set forth in the Bylaws.

ARTICLE VI. BYLAWS

The Directors by majority vote may suspend, amend, delete or adopt such Bylaws as they deem appropriate.

ARTICLE VII. AMENDMENTS

These Articles may be amended by a majority vote of the Directors.

ARTICLE VIII. REGISTERED AGENT

The location of the registered office, and the Registered Agent, of the Corporation is Jason Ball, 9428 N. Government Way, Hayden, Idaho 83835.

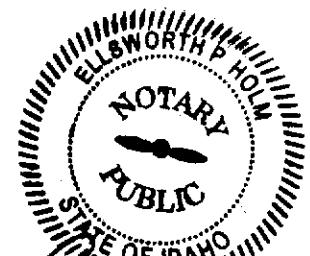
ARTICLE IX. DURATION AND DISSOLUTION

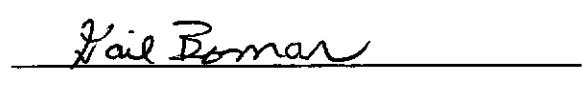

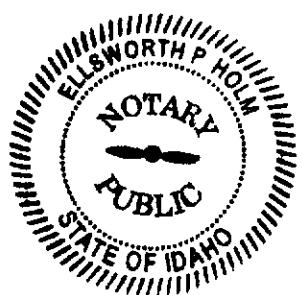
