The undersigned natural person, of the age of 21 or more, acting to form a corporation under the Idaho Business Corporation Act, does hereby state the following:

ARTICLE I. The name of the corporation shall be Superhouse, Inc.

ARTICLE II. The duration of the corporation shall be perpetual.

ARTICLE III. The purpose for which the corporation is organized shall be the transaction of any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act..

ARTICLE IV. The aggregate number of shares which the corporation shall have authority to issue is one million (1,000,000) shares, no-par.

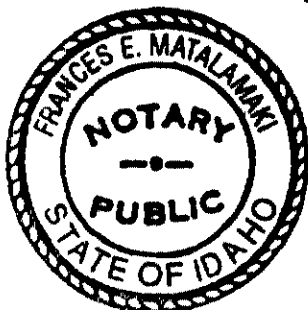
ARTICLE VII. The name and address of the person who is to act as the incorporator is James F. Otton, 218 18th Avenue, Lewiston, ID 83501.
