ARTICLES OF INCORPORATION

OF

MICHAEL G. MELENDEZ, M.D., CHARTERED

The undersigned, who is duly licensed to practice the profession of medicine and diagnostic radiology in the State of Idaho, does hereby form a professional corporation pursuant to the provisions of Idaho Code 30-1301 et seq., being the Idaho Professional Service Corporations Act, for the purpose of rendering medical and radiological services, and hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be MICHAEL G. MELENDEZ, M.D., CHARTERED.

ARTICLE II

The purposes for which this corporation is formed are as follows:

- (1) To engage in the general practice of medicine and diagnostic radiology.
- (2) To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real or personal property necessary for the rendering of professional services specified above.
- (3) To do such acts and carry on such business as may be permitted by the Idaho Professional Service Corporations Act, subject to the limitations thereof.

ARTICLE III

ARTICLE IV

The name and post office address of the incorporator hereof is:

ARTICLE V

The corporation shall be governed by a Board consisting of one director. The director shall be a stockholder in the corporation, and shall be elected by the stockholders, in the event the number of stockholders shall exceed one.

The duration of this corporation shall be perpetual.

The director of the corporation may, from time to time, adopt Bylaws not inconsistent herewith, or with the provisions of Idaho State law, for the governing of the affairs of the corporation, which may include provisions with respect to the alienation of shares of stock of this corporation and also provide for the purchase or redemption by the corporation of its shares
