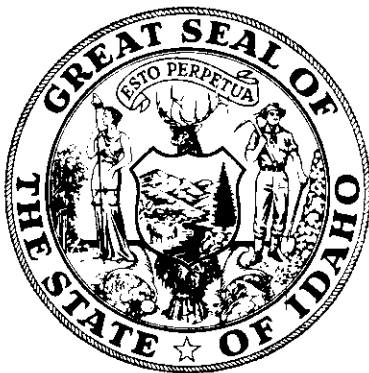

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
DON R. LaVOIE DISTRIBUTING, INC.

* * * * *

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The following amendments to the Articles of Incorporation were adopted by shareholders owning 100% of the outstanding shares of the Corporation on May 5, 1990, in the manner prescribed by Idaho Business Corporation Act:

SECOND: ARTICLE IX of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

The aggregate number of shares which the corporation shall have authority to issue is 100,000 with a par value of \$5 per share.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 7,826 shares, the number of shares entitled to vote thereon was 7,826.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

FIFTH: The number of shares voted for such amendment was 7,826 shares; and the number of shares voted against such amendment was none.
