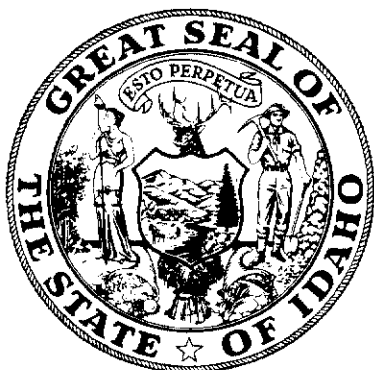

ARTICLES OF INCORPORATION
OF
YOUTH WITH A MISSION. IDAHO, INC.

WE, the undersigned, have voluntarily associated out-
selves together for the purpose of forming a corporation under
the General Nonprofit Corporation Law of the State of Idaho, and
we hereby certify the following:

I.

That the name of this corporation is YOUTH WITH A MIS-
SION IDAHO, INC.

II.

A. That the specific and primary purposes for which
this corporation is formed are as follows:

1. To establish a religious service organization
for the promotion of the Gospel of Jesus Christ
throughout the world.
2. To present an open door for sacrificial service
to young men and young women with gifts, talents
and/or material assets which they may desire to
dedicate to the extension of world wide
missions.
3. To encourage enlistment into the missionary
service of volunteers from every vocation either
as assistants to Gospel missionaries or as
"goodwill ambassadors" preparing the way for
the Gospel Ministry.
4. To increase missionary giving and encourage
volunteers for the mission field through the
promotion of new missionary projects such as
church buildings, schools, homes and orphanages.
5. To build an organization available to evangel-
ical denominations and offer a service elastic
enough to include men and women of all ages who
are interested in promoting the Gospel message
in foreign lands.

B. The general purposes or powers are as follows:

1. To lease, purchase, hold, have, use and take
possession of and enjoy in fee simple or other-
wise any personal or real property necessary
for the uses and purposes of the corporation,
and to sell, lease, mortgage, deed in trust,
alien or dispose of the same at the pleasure of
the corporation, and for the uses and purposes
for which said corporation is formed, and to
buy and sell real or personal property and to
apply the proceeds of sale, including any and
all income, to the uses and purposes of the
corporation.

- 1 2. To receive property by gift, devise or bequest,
2 subject to the laws regulating the transfer of
3 property by will, and to otherwise acquire and
4 hold property, real or personal, including
5 shares of stock, bonds and securities of other
6 corporations.
- 7 3. To act as trustee under trust incidental to the
8 principal purposes of the corporation, and to
9 receive, hold, administer and expend funds and
10 property subject to such trust.
- 11 4. To own and operate land and equipment useful to
12 carry out the purposes of the corporation, such
13 as radio stations, electronic equipment,
14 vehicles of transportation, tape recorders and
15 public address systems.
- 16 5. To do all other acts permitted by the law to non-
17 profit corporations which may be necessary or
18 expedient for the administration of the affairs
19 and attainment of the purposes of the corpora-
20 tion.

21 III.

22 That the period of existence shall be perpetual.

23 IV.

24 The address of the initial registered office of the
25 corporation is Rapid River Ranch, Riggins, Idaho County, Idaho,
26 and the name of its initial registered agent at such address is
27 Jerry Praetzel.

28 V.

29 That this is a corporation which does not contemplate
30 pecuniary gain or profit to the members thereof.

31 VI.

32 That the number of persons who shall act in the capacity
of Directors of this corporation shall be three or more, and that
the names and places of residents of those who are appointed to
act until the selection and qualification of their successors are
as follows:

VIII.

That the said three persons who will act in the capacity of Directors may be designated as Trustees, but shall be subject to all laws of this State relating to Directors.

IX.

That the authorized number and qualifications of its members, the different classes of membership, voting and other rights and privileges, shall be set forth in the By-Laws of the said corporation.

X.

That this is a corporation organized and operated exclusively for religious and charitable purposes, no part of the net earnings of which inures to the benefit of any private share holder or individual, and no personal gain is expected or shall be received by any officer, member or other individual; that in case of its dissolution all of its assets shall be transferred to Youth With a Mission International Council, or if said organization is unable or unwilling to accept such transfer than this corporation's assets shall be used for distribution to one or more organizations organized and operated exclusively for religious, charitable, educational, scientific or literary purposes.
