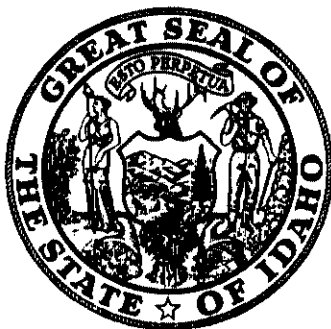
CERTIFICATE OF INCORPORATION OF

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles Of Incorporation for such corporation:

FIRST: The name of the corporation is; RIVER VIEW FARMS, INC.

SECOND: The period of the corporation is; PERPETUAL

THIRD: The purpose for which the corporation is organized are the transactions of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act; FARMING & RANCHING.
