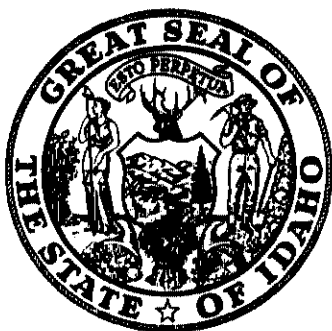
### CERTIFICATE OF INCORPORATION OF

## ARTICLES OF INCORPORATION

1. Calvary Chapel Meridian, Inc.
2. The initial registered office is located at 3590 wadsworth dr. Boise, Idaho 83704.
3. The name of the initial registered agent is Robert C. Jacobson.
4. The period of duration of Calvary Chapel Meridian, Inc. shall be perpetual, beginning on February 2, 1992. Each fiscal year will end on January 31st of each successive year thereafter.
5. Calvary Chapel Meridian, Inc. will be a not for profit organization, but will be a church with the purpose of proclaiming the gospel message of our Lord Jesus Christ.
6. The purpose for which the corporation was organized as a church is to; win men and women to faith in Jesus Christ as Lord and Savior; to increase christian faithfulness "as good stewards of the manifold grace of God" (1Peter 4:10); to encourage individual christians toward attaining "the measure of the fullness of Christ" (Ephesians 4:13); to serve the community in every possible christian way; to send personnel and christian influence throughout the world by prayers and gifts for missions.




