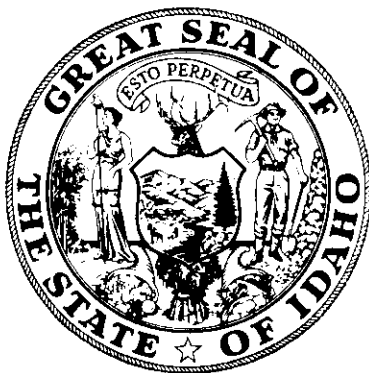

ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is: HAGBY U.S.A., INC.

II.

The period of its duration is perpetual.

III.

Its purpose is to transact the business of selling and manufacturing diamond core drilling products and for all other activities not forbidden by law.

IV.

It shall have authority to issue 100,000 shares, all of one class, \$1.00 par value.

Each shareholder shall have pre-emptive rights.




