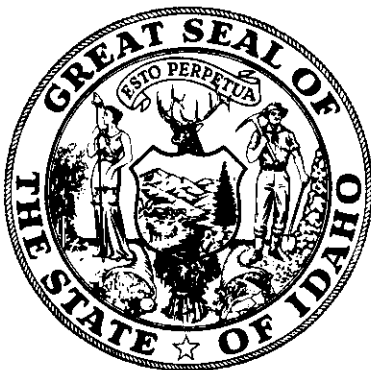

ARTICLES OF INCORPORATION
of

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, all of whom are citizens of the United States of America and over the age of 21 years, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

I.

The name of the corporation shall be "INTERMOUNTAIN COMPUTER SERVICES, INC."

II.

Said corporation shall have a perpetual existence unless dissolved pursuant to the statutes of the State of Idaho.

III.

Said corporation is organized to transact any and all lawful business for which corporations may be incorporated under Idaho Business Corporation Act.

The corporation shall have authority to issue 1,000 shares with par value of each share in the amount of \$10.00.




