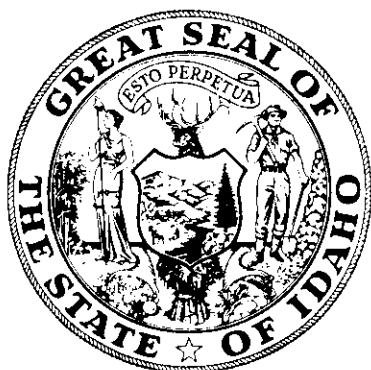

ARTICLES OF INCORPORATION
OF
SALMON RIVER ADVENTURES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SALMON RIVER ADVENTURES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(a) To conduct and carry on a general outfitting, float boat and kayak guiding business and to transact all business which outfitters and guides are authorized and empowered to transact in and by the provisions of the State of Idaho; including, but not limited to, advertising and holding itself out to the public for hire, providing facilities and services for the conduct of boating, fishing, or other recreational excursions, and maintaining leases or otherwise using equipment or accommodations for such purposes including boats or other floating craft.

(b) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: It shall have authority to issue One Thousand (1,000) shares, all of one class, One Hundred and No/100 Dollars (\$100.00) par value.

FIFTH: The address of its initial registered office is 400 No. St. Charles Street, Salmon, Idaho 83467. The name of its initial registered agent at such address is Richard L. Blake.
