ARTICLES OF AMENDMENT

To The

Articles of Incorporation

Of

TRADE DOLLAR LEASING COMPANY

Pursuant to a resolution of the Board of Directors of TRADE DOLLAR LEASING COMPANY adopted on the 12th day of June, 1929, a special meeting of the stockholders of said Company was called to be held at the office of the Company in Boise, Idaho, at 8:00 o'clock P. M. on the 15th day of July, 1929, for the purpose of amending the Articles of Incorporation of said Company by increasing its capital stock from forty thousand shares to fifty thousand shares, of the par value of One (\$1.00) Dollar each.

Written notice of the time, place and purpose of the meeting was given by the secretary to all stockholders of the Company at least thirty days prior to the day named for said meeting, such written notice being placed in the United States mail at Boise, Idaho, postage prepaid, and addressed to each shareholder of the Company at his last known post office address.

Said meeting was duly held at the time and place fixed for the same in said notice, 37.502 shares being represented either in person or by proxy, said number of shares constituting more than two-thirds of the voting power of all shareholders.

Thereupon, the following resolution was proposed and was adopted by an affirmative vote of more than two-thirds of the voting power of all shareholders of the corporation, each share being entitled to one vote, to-wit, by an affirmative vote of

"RESOLVED, That the capital stock of TRADE DOLLAR LEASING COMPANY be increased from forty thousand shares to fifty thousand shares, of the par value of One (\$1.00) Dollar each."

Thereupon, by a vote of the holders of more than two-thirds of the voting power of all shareholders of the company, to-wit, by an affirmative vote of 37.502 shares, Paragraph VI of the Articles of Incorporation of TRADE DOLLAR LEASING COMPANY was amended to read as follows:

VI.

"The amount of the capital stock of this corporation is Fifty Thousand (\$50,000.00) Dollars, divided into 50,000 shares of the par value of One (\$1.00) Dollar each."
