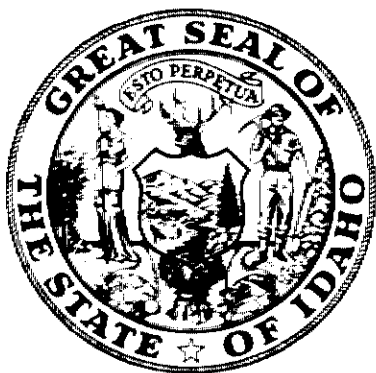

ARTICLES OF INCORPORATION

We, the undersigned natural persons of age eighteen (18) or more and residents of the State of Idaho do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of this nonprofit corporation is Cornerstone Christian Fellowship, Inc.

ARTICLE TWO

STATUS

The corporation is a nonprofit corporation.

ARTICLE THREE

AUTHORIZATION

The corporation shall proceed under Title 30, Chapter 3, of the laws of the State of Idaho.

ARTICLE FOUR

PURPOSE

The purpose for which this corporation is organized shall be as follows:

1. To work for the restoration of the family of God as expressed in the home and in the church, both locally and in outreach to the whole body of Christ.
2. To witness of salvation in the Lord Jesus Christ to the unsaved.
3. To be a creative center for the development and support of Christian music ministries.
4. To provide for, and actively engage in, ministry to the youth in our area.
5. To feed the hungry, clothe the naked, visit the sick and incarcerated, and contend for widows and orphans.

## ARTICLE FIVE

### PLACE OF WORSHIP

The post office address of the corporation's principal office and place of worship is 103 Bentley Place, City of Post Falls, State of Idaho.

## ARTICLE SIX

### DURATION

The period of duration of this corporation is perpetual.

## ARTICLE SEVEN

### NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

## ARTICLE EIGHT

### MANAGEMENT

The management of the affairs of this corporation is ultimately vested in its members pursuant to Idaho Code §314(c). The number of elders constituting the initial board of elders of the corporation is not less than seven (7) or one (1) elder for every twenty-five (25) adults in average attendance at worship in a six-month period. The initial board shall have two (2) elders.


