ARTICLES OF INCORPORATION

OF

LINK'S SCHOOL OF BUSINESS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, Howard full-age
E. Erickson, Rudolph I. Upton and Hazel L. Upton,/citizens of the United States, have associated ourselves for the purpose of forming a body corporate and politic, under and by virtue of the laws of the State of Idaho, and in accordance with the provisions of the laws of said state, do hereby make, execute and acknowledge this certificate in writing of our intentions so to become a body corporate and politic, under and by virtue of said laws in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I

The corporate name of the said corporation herein is:

LINK'S SCHOOL OF BUSINESS, INC.

ARTICLE II

The purposes for which said corporation is formed are to engage in the business of maintaining and conducting business schools and colleges; conducting business and trade courses in subjects of all kinds and engaging in such other business of a similar nature or related thereto and to engage in any and all activities with the operation of the business to include manufacturing, purchasing, or otherwise acquiring, owning, mortgaging, pledging, selling, assigning and transferring, or otherwise disposing of, investing, trading in, dealing in, and dealing with goods, wares, merchandise and real and personal property of every class and

description; engaging in, doing and performing any enterprise, act or vocation that a natural person might do or perform; engaging in any commercial, industrial and agricultural enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho.

ARTICLE III

Said corporation is to have perpetual existence.

ARTICLE IV

The amount of the capital stock of said corporation shall be Twenty-Five Thousand (25,000) shares of common capital stock, having a par value of One (\$1.00) Dollar per share. Each share of stock shall entitle the holder thereof to one (1) vote at all stockholders' meetings. Said stock, when issued, shall be fully paid and non-assessable.

ARTICLE V

The affairs and management of our said corporation are to be under the control of a board of directors consisting of three members, not necessarily shareholders, and Rudolph I. Upton, Hazel L. Upton and Howard E. Erickson are hereby selected to act as said directors and to manage the affairs of said corporation for the first year of its existence or until their successors are elected and qualified.

ARTICLE VI

Cumulative voting shall not be allowed in the election of directors.

ARTICLE VII

The location and post office address of the registered office of the corporation is 1223 Main Street, Boise, Idaho. Part or all of the business of said corporation may be carried on beyond the limits of the State of

Idaho, and in such other places as the Board of Directors shall from time to time determine, and this corporation may operate in any state, nation, kingdom or country in the whole world. Stockholders' meetings, and those of the Board of Directors may be held outside the State of Idaho. All books of the corporation required to be kept by the laws of the State of Idaho shall be kept at the office of the corporation at 1223 Main Street, Boise, Idaho.
