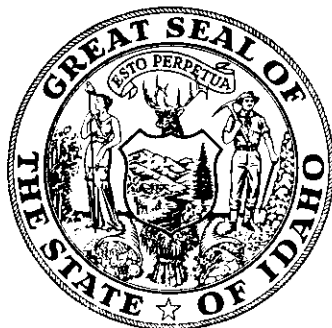
### CERTIFICATE OF WITHDRAWAL OF

8. All known creditors or claimants have been paid or provided for and the corporation is not involved in or threatened with litigation in any court in the State of Idaho.

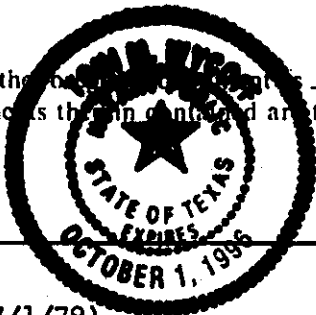
