ARTICLES OF INCORPORATION OF
FAITH EVANGELICAL LUTHERAN CHURCH OF POCA TELLO,

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned, hereby associate ourselves together for the purpose of forming a religious nonprofit corporation under the laws of the State of Idaho, and do hereby adopt the following articles of incorporation:

I.

The name of this corporation shall be FAITH EVANGELICAL LUTHERAN CHURCH OF POCA TELLO, BANNOCK COUNTY, IDAHO INC.

II.

The purpose of the corporation is:

1. To have the word of God preached among us in all truth and purity.
2. To have the Sacrament administered according to divine institution.
3. To give to all the benefits of Christian education.
4. To administer charity according to the confessional standards of the Lutheran Church.

III.

The corporation shall have power to purchase and own property needed for carrying on the work for which it is formed; and to sell or mortgage the same for such purpose as necessity may demand; power to enter into all contracts necessary for the purpose for which the corporation is formed; and perform all duties required by the constitution and by-laws of FAITH EVANGELICAL LUTHERAN CHURCH of Pocatello, Bannock County, Idaho Inc. 1958, and be bound thereby.

IV.

If at any time a separation should take place on account of doctrine, the property of the congregation and all benefits therewith connected shall remain with those voting members who continue to adhere in confession and practice to Article Three of the Constitution of FAITH EVANGELICAL LUTHERAN CHURCH

of Pocatello, Bannock County, Idaho Inc. (1958). In the event the congregation should totally disband, the property and all rights connected therewith shall be transferred to the Northwest District of THE LUTHERAN CHURCH MISSOURI SYNOD.

V.

The period of duration of the corporation will be perpetual.

VI.

The location and post office address of the registered office of the corporation is 856 West Eldredge Road, Pocatello, Idaho 83201.

VII.

The name and address of the registered agent of the corporation is Reverend Bruce Kolasch, 856 West Eldredge Road, Pocatello, Idaho 83201.

VIII.

That a meeting for the election of directors was held by the members of the Church named, at 7 o'clock P.M., on June 30th, 1991, at 856 West Eldredge Road, in Pocatello, Idaho, in the Church Building of the Church, the same being legally called, by publication and by a posted notice, and that at said meeting a majority of the members of the Church Association then present voted at such meeting and election, and the following members of the Church named were elected to serve as directors for two years, and until their successors are elected and qualify:
