TO THE
ARTICLES OF INCORPORATION
OF SECRETARY OF
ELMFALLS, INC. STATE

(Hereafter To Be Known As MEXWEST, INC.)

Pursuant to the provisions of Idaho Code Section 30-1-61, the undersigned corporation, adopts the following Articles of Amendment to its Articles of Incorporation.

I.

The name of the corporation is ELMFALLS, INC., but is to be hereafter changed to MEXWEST, INC.

II.

The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on the 13th day of January, 1983, in the manner prescribed by the Idaho Business Corporation Act:

Amended Provision: Article First of the Articles of Incorporation is hereby amended and the following supercedes and takes its place:

FIRST: The name of the corporation is MEXWEST, INC.

III.

The only shares authorized for issuance at the time of the adoption of the amendment were common shares of which

39,999 shares had been authorized and all were issued and outstanding. The 39,999 shares of common stock were entitled to vote on the amendment. Of those 39,999 shares the entire number voted for the amendment and none voted against.

IV.

The amendment does not provide for an exchange, reclassification or cancellation of issued shares.


V.
