7 Know all Men by these Presents, that we the
8 undersigned bona fide residents of the State of
9 Idaho have this day mutually associated our-
10 selves together for the purpose of forming a
11 Private Corporation under the laws of the State
12 of Idaho. And to that end we do hereby make,
13 execute and acknowledge these Articles of
14 Incorporation, And we do hereby certify and
15 declare.

16 First that the name of this Corporation shall
17 be "The Enterprise Wetch Company"

18 Second that the purpose for which this Corpor-
19 ation is formed is to purchase, construct, own and
20 maintain a Water Wetch to be taken out of the
21 Payette River in Ada County State of Idaho, at a
22 Point about 150 yds. East of the House owned
23 by John Conery in Sec. 11, T. 6 N. R. 2. West, running
24 South of West Four Miles (4), thence South to near
25 Foot Hills, thence in a North Westely direction for
26 a distance of about 8 miles to the West line of
27 Section 3, T. 6 N. R. 3. West. And also to locate, appro-
28 priate, purchase, hold and possess Water Rights,
29 to be used in connection with said ditch for
30 the purpose of irrigation and domestic uses.

31 Third that the place where the Principal Business
32 of this Corporation is to be transacted is at Falls
33 Store Ada County, State of Idaho.

Fourth, that the term for which said corporation is to exist, shall be fifty (50) years from and after the date of its incorporation.

Fifth, that the number of its directors shall be five (5), and that the names and residences of those who are appointed for the first year are as follows,
