ARTICLES OF INCORPORATION

OF

THE SLATE CREEK MINING COMPANY.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of Washington Territory. And we do hereby certify in triplicate, as follows:
