## ARTICLES OF INCORPORATION OF CONKLING PARK BOATERS' ASSOCIATION I, INC. An Idaho Corporation

THE UNDERSIGNED, acting as incorporator of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

THE NAME OF THE CORPORATION IS CONKLING PARK BOATERS' ASSOCIATION I, INC.

ARTICLE II.

THE PERIOD OF THE corporation's duration is perpetual.

ARTICLE III.

The purpose or purposes for which this corporation is organized is/are: Ownership of slips designed for boat moorage; care and maintenance of docks, covers and slips; any and all other activities authorized by the State of Idaho.

ARTICLE IV.

THE MEMBERSHIP of the corporation shall consist of owners of boat slips in designated docks belonging to the corporation, with each slip being entitled to one vote in all proceedings of the corporation.

## ARTICLE V.

The address of the initial registered office of the corporation is 9765 Easy Street, Hayden Lake, Idaho 83835, and the name of its initial registered agent at such address is JAMES M. ENGLISH.
