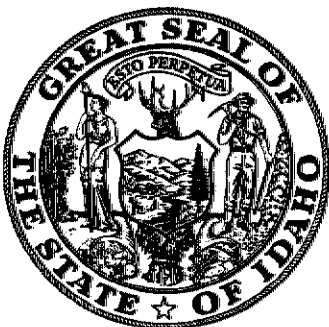

We the undersigned, being over the age of eighteen, in order to form a corporation pursuant to the Corporate Code of the State of Idaho, hereby certifies as follows.

ARTICLE I

That the name of this corporation is DIVON Enterprises, Inc.

ARTICLE II

The purpose of said corporation is to provide multiple services primarily for, but not limited to, individuals with developmental disabilities. Said services shall include, but not be limited to, transportation and educational services.

ARTICLE III

This is a non-stock, non-profit corporation.

ARTICLE IV

The duration of said corporation shall be indefinite.

ARTICLE V

That upon desolving the corporation any profits shall be dispersed by the Board of Directors in a manner not inconsistent with Idaho law regarding the distribution of assets upon dissolution of a non-profit corporation..

That membership in said Corporation shall be granted as deemed appropriate and in the best interest of the Corporation in accordance with the bylaws of the Corporation.

ARTICLE VII

That the Corporation shall apply to the Internal Revenue Service for tax exempt status under Section 501(c) (3) of the Internal Revenue of 1954 (or the corresponding provisions of any future United States Law) and in accordance with the Corporate bylaws.
