

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being  
members of the Roman Catholic Church, have this day voluntarily  
associated ourselves together for the purposes of forming a corpora-  
tion, under the laws of the State of Idaho. And we do hereby  
certify,

-I-

That the name of said corporation is "URSULINE CONVENT OF OUR  
LADY".

-II-

That the purposes for which it is formed are,

FIRST:-

To found, establish, build, conduct and maintain an Academy and  
Seminary of learning at Moscow, in Latah County, State of Idaho, and  
to do and perform any and all things ancillary, related, pertaining  
necessary or proper to or connected with, the founding, establishing,  
building or maintaining of such Academy or Seminary, which may be  
found necessary or proper in the conducting of the business thereof.

SECOND:-

To have the power of perpetual succession.

THIRD:-

To take by purchase, gift, grant, devise or bequest and to hold  
the same for the use of such corporation, any real estate or personal  
property whatsoever, and to sell, dispose of, convey, mortgage, or  
otherwise use such real estate or personal property, in such manner  
as may be considered most conducive to the interests of the in-  
stitution.

FOURTH:-

To purchase, own, sell or dispose of promissory notes, bonds, stocks  
accounts, choses in action, or other evidences of indebtedness, for  
the use and benefit of the corporation, in the usual course of the  
transaction of its business.

FIFTH:-

To make, execute and deliver its promissory note or notes, <sup>or bonds</sup> and  
to secure the same, if found necessary, either by mortgage security  
on its real or personal property, or both, for the purposes of  
securing such indebtedness, incurred in connection with the founding,  
establishing, building, conducting or maintaining of its institution

of learning.

SIXTH:-

To carry on such course of studies as may be found met or proper from time to time, in each Department of its institution, and to grant such literary honors and degrees as are usually granted by like institutions, and to execute and give diplomas in testimony thereof.

SEVENTH:-

To do and perform any other act or thing ancillary, relative, pertaining, necessary or proper to or connected with any or all of the kinds of business or businesses heretofore mentioned; to carry on such operations and enterprises, and to do any and all things in connection therewith, as may be permitted by the laws of the State of Idaho or any other State within the United States in which it may be doing business, and which may be necessary or convenient in the conduct of the Company's business.

-III-

That the place where its principal place of business and where the institution is to be located is Moscow, in Latah County, State of Idaho.

-IV-

That the number of its Directors shall be Five(5) and the names and addresses of those who are first appointed are.
