I, the undersigned natural person of the age of 21 years or more acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE II

NAME OF CORPORATION: The name of the corporation
hereby formed shall be L. J. Sorensen, Inc.

ARTICLE III

DURATION: The period of its duration shall be perpetual.

ARTICLE III

OBJECTS AND PURPOSES: The purpose or purposes for which the corporation is organized is to engage in all aspects of marketing products. The corporation shall further have unlimited power to engage in and do any lawful act concerning any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act and any amendments thereto.

ARTICLE IV

AUTHORIZED SHARES: The corporation shall have authority

to issue One Hundred Thousand (100,000) shares of stock which stock shall be of one class only which shall be common voting stock at no par-value. The common stock shall have unlimited voting rights provided in the Idaho Business Corporation Act.

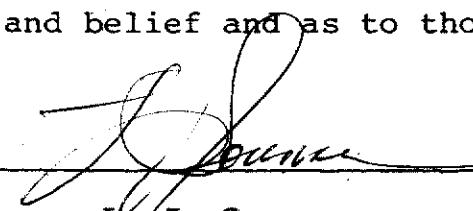
ARTICLE VIII
