THE UNDERSIGNED, acting as incorporators ^{of a corporation}

under the Idaho Business Incorporation Act, adopt the following
Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Hulse Farms, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is
organized are to raise, purchase and market agricultural
commodities and livestock, plus any other thing for which
corporations may be incorporated under the Idaho Business
Corporation Act.

FOURTH: The aggregate number of shares which the corporation


