

RESTATED

ARTICLES OF INCORPORATION

OF

BOB'S INSULATION & SUPPLY COMPANY, INC.

The undersigned, acting as all of the directors of Bob's Insulation Supply Company, Inc. (the "Corporation") pursuant to Section 30-1-1002 and 30-1-1007 of the Idaho Business Corporation Act, adopt the following Restated Articles of Incorporation.

ARTICLE I

The name of the corporation is BOB'S INSULATION & SUPPLY COMPANY, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares at no par value.

ARTICLE V

Provisions denying preemptive rights are none.
