## First.

That the name of said corporation is The Henry Stampede and Stockmens! Reunion.

### Second.

That the purposes for which it is formed are to carry on the business of furnishing amusement and entertainment to the public by managing, directing and staging an annual show, round-up, rodeo, and race meet and all incidents thereto belonging or appertaining; to erect, maintain, purchase or rent, hire, lease, let or otherwise acquire or dispose of buildings or structures for said purposes; to acquire, sell, mortgage, lease, or otherwise acquire or dispose of all real or personal property necessary or convenient to such basiness; and generally to acquire, hold, manage and dispose of property of every kind pertaining to such business and to do everything necessary and proper to the conduct of said business.

#### Third.

That the place where its principal business is to be transacted shall be Henry, County of Caribou, State of Idaho.

That the term for which it is to exist is fifty years from and after the date of its incorporation.
