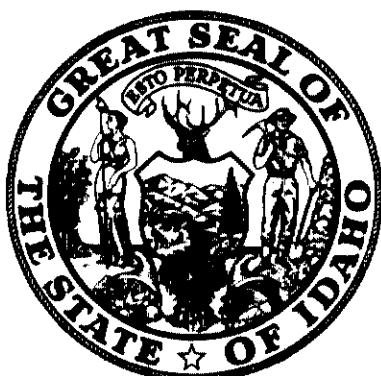
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Professional Service Corporation Act, adopt the following articles of incorporation:

I.

The name of the Corporation is: Perkins & Associates, P. A.

II.

The Corporation is to have perpetual existence.

III.

The Corporation is organized for the sole and specific purpose of rendering Professional Service as Chiropractic Service.

IV.

The authorized Capital of the corporation consists of a single class of stock, the total number of authorized shares is 100 with a par value of \$ None, and an aggregate par value of \$ None.

V.

The holders of shares of stock in this corporation will be only those whom are duly licensed or otherwise legally authorized to render the same specific professional services as those for which the corporation was incorporated.
