ARTICLES OF INCORPORATION OF THE
WILSON COMMUNITY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, do hereby certify as follows:

I

That the name of the corporation shall be: Wilson Community, Inc.

II

The corporation shall be nonstock and no dividends or pecuniary profits shall be declared to the members thereof.

III

The undersigned have associated and by these presents do hereby associate themselves together for the purpose of forming this corporation under the provisions of Title 30, chapter 10, of Idaho Code to form a corporation and cooperative association for the establishment, maintenance, and management of a club for literary purposes, mutual improvement, and the promotion of social intercourse among its members, to the end that the members shall become more efficient in their homes, broader in their sympathies, and more effective and forceful in civic enterprises; to acquire by grant, gift, purchase, devise or bequest, and to hold and dispose of such property as the purposes of the corporation shall require, subject to such limitations as may be prescribed by law, for the benefit of the members and not for pecuniary profit, and to specifically own real estate and a community building for carrying out purposes of this corporation.

IV

The corporation is to have perpetual existence.

V

The location, registered office and post-office address of said corporation shall be: Star Route, Melba, Idaho.

VI

The members of this corporation shall consist of the persons hereinafter named as incorporators and such other persons as from time to time hereafter may become members in the manner provided by the by-laws; the voting power and the property rights and interest of all members shall be equal and each member shall be entitled to one vote on any and all questions coming before the members.
