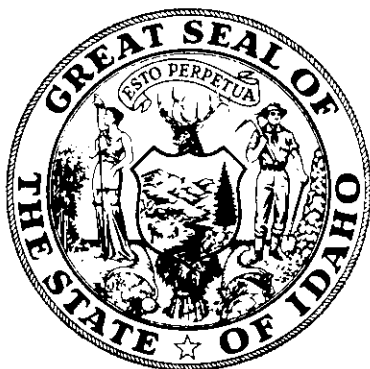

ARTICLE I

NAME

The name of this corporation is WOOD RIVER  
BROADCASTING, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSES

The purpose for which this corporation is

Avenue, P. O. Box 297, Ketchum, Idaho 83340.

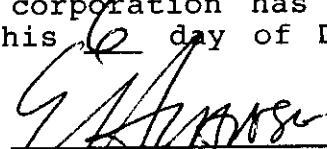

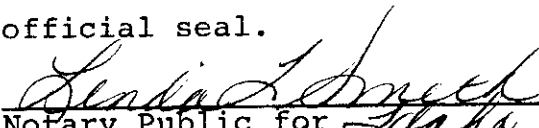
