**CERTIFICATE OF INCORPORATION**

I, ~~XXXXXXXXXX~~, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**MAGIC VALLEY AVIATION BOOSTERS INC.**

was filed in the office of the Secretary of State on the **twentieth** day of **April,** A. D. One Thousand Nine Hundred **Fifty-Nine,** and is duly recorded on Film No. **106** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Twin Falls,** in the County of **Twin Falls,** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
MAGIC VALLEY AVIATION BOOSTERS INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of the age of twenty one years or over and citizens of the United States have this day voluntarily associated ourselves together for the purpose of forming a non profit Corporation under the Laws of the State of Idaho, and to that end we do hereby adopt Articles Of Incorporation as follows:

ARTICLE I.

NAME AND PLACE OF BUSINESS

The name of the Corporation shall be Magic Valley Aviation Boosters Inc. and its principle place of business shall be Twin Falls, Idaho.

ARTICLE II.

DURATION

The period of the duration of the Corporation shall be perpetual, subject to dissolution in the manner provided by Law.

ARTICLE III.

POWERS AND PURPOSES

The Corporation shall have the power to acquire, own and sell or lease real estate for the purpose of the Corporation, but the Corporation shall not engage in any business, trade, avocation, or profession for gain or profit. This Association shall have all the powers, privileges and rights necessary or convenient for carrying out the purposes for which this Association is formed; and the members hereby claim for this Association all of the benefits, privileges, rights and powers created, given, extended or conferred by the Provisions of Title 30, Idaho Code, or any additions or amendments thereto, pertaining to non profit Cooperative Associations. The purpose of this organization shall be to promote interest and education in the Field of Aviation in the State of Idaho.

ARTICLE IV.

MEMBERS

Any person, corporation, association or co-partnership who is interested in the promotion of interest and education in the Field of Aviation in the State of Idaho and the purposes of this corporation shall be eligible for membership. The rights of all members shall be equal.

Any eligible person, corporation, association or co-partnership may apply for membership upon an application form prescribed by the Board of Directors or by any officer designated by the Board of Directors, and upon payment of the required membership fee as prescribed by the Board of Directors the applicant shall become a member and shall be entitled to a Membership Certificate.

ARTICLE V.

MEETINGS

An annual meeting of the association shall be held at the office of said Association at Twin Falls, Idaho, or such other place as shall be designated by the Board of Directors at 8:00 P. M. on the 9th day of January of each year, or at such other time as the Board of Directors shall fix between the 2nd day of January and the 31st day of January of each year, for the purpose of electing Directors and transacting such other business as may come before the meeting.

ARTICLE VI.

DIRECTORS

There shall be the number of four directors of the Corporation. They shall be the President of the Magic Valley Aviation Boosters Inc., the Vice President of the Magic Valley Aviation Boosters Inc., the Treasurer of the Magic Valley Aviation Boosters Inc., and the Secretary of the Magic Valley Aviation Boosters Inc. These shall be duly elected according to the By-Laws of the Magic Valley Aviation Boosters Inc.

ARTICLE VII

GOVERNING INTERNAL AFFAIRS

The internal affairs of the corporation shall be governed according to the By-Laws of the Magic Valley Aviation Boosters Inc. and upon the dissolution of the Corporation the assets of the Corporation shall be turned over to the members of the Association, after payment of all just debts.

ARTICLE VIII

MEMBERS NOT LIABLE FOR DEBTS OF ASSOCIATION

The members shall not be individually liable for the debts of this association.

ARTICLE IX

INITIAL BOARD OF DIRECTORS

The number of initial Board Members shall be four and they shall act as the incorporators of the corporation. Their names and addresses are as follows:

ARTICLE X


