1. NAME.

The name of this Limited Partnership shall be the B. JOHN GALBRAITH FAMILY LIMITED PARTNERSHIP.

2. CHARACTER OF BUSINESS.

9. ADDITIONAL CONTRIBUTIONS.

10. RETURN OF CONTRIBUTIONS.

Any Partner shall have a right to receive distributions from the Limited Partnership at least annually.

12. RIGHT TO SELL OR ASSIGN.

There shall be no priority as to the distribution of income or the return of capital between the Limited Partners.

15. DEATH OF A GENERAL PARTNER.

In the event of the death of a General Partner, the remaining General Partners may, at their election, continue the business of the partnership. If the remaining General Partners elect to continue the business of the Limited Partnership, the estate of such deceased General Partner shall sell such general partnership to the partnership at a price and on the terms provided in the "Purchase and Sale Agreement."

16. PROPERTY OTHER THAN MONEY.

In the event that any partner shall be entitled to a return of his contribution, if it has been made in other than cash, said partner shall be entitled to receive only the cash value of his contribution.
