

Articles of Incorporation

The undersigned certify that:

- 1) The name of the corporation will be Christian Family School And Resource Center Inc.
- 2) The Christian Family School And Resource Center Inc. will be a non-profit corporation established in perpetuity for the purposes of conducting a private school to teach conventional academic subjects (such as, but not limited to, Math, Science, History, English, Religion) from a Christian perspective to students in grades K-12, and of providing families \*with educational resources.
- 3) Said corporation will have three incorporators and members:

- 4) Management of said corporation will be vested in said members pursuant to section 30-314(c), Idaho Code.
- 5) The initial registered office of said corporation will be on Boundary County Road 30A at HCR 85 Box 12, Bonners Ferry, Id., 83805
- 6) The initial registered agent will be Ray Chaffee, HCR 85 Box 12, Bonners Ferry, Id. 83805
- 7) No part of the earnings of said corporation will inure to the benefit of , or be distributable to its members, trustees, officers, or other private persons, except that the corporation will be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise trying to influence legislation; and the corporation shall not participate in, intervene in (including the publishing and distribution statements) any political campaign on behalf or in opposition to candidate for public office. Notwithstanding any other provision of these articles, this corporation will not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
- 8) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or shall be distibuted to the federal government, or to a state or local government, for a public purpose. Any assets not so disposed of

will be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court will determine, which are organized and operated exclusively for such purposes.

9) The school will not discriminate on the basis of race, color, or national or ethnic origin in any of its admissions policies, educational policies, scholarship progams, or any other school-administered policies and functions.
