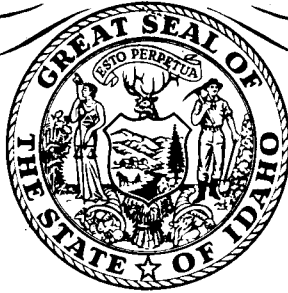

KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned, being the stockholders of EMBERS, INC., a corporation, formed the 18th day of May, 1965, for the purposes stated in the Articles of Incorporation, heretofore and on the 18th day of May, 1965, filed with the Secretary of State, State of Idaho, do hereby certify that the Articles of Incorporation, and particularly Article V thereof, so filed, be, and the same is hereby amended to read as follows:

"ARTICLE V

The amount of the capital stock of the corporation shall be \$25,000.00, to be divided into 250 shares of the par value of \$100.00 each, and said shares of stock shall be non-assessable."






