CERTIFICATE OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION

The president and secretary of Skyline Advertisers' Sales, Inc., a Nevada corporation, do hereby certify that the Board of Directors of this corporation duly passed a resolution on the 28th day of August, 1958 to the effect and declaring that changes in Article XII of the Articles of Incorporation of this corporation were desirable, and calling a special meeting of the stockholders of said corporation to take action thereon; that on the 28th day of August, 1958, a meeting was held of the stockholders of said corporation, notice of which meeting was waived by all of the stockholders, and that said stockholders duly adopted by unanimous vote the following resolution:

RESOLVED that paragraph 3 of Article XII of the Articles of this corporation be amended to read as follows:

"It is understood and agreed that the beneficial owners of the Class A stock are the owners directly or indirectly of the following television stations: KID-TV, Idaho Falls, Idaho; KLIX-TV, Twin Falls, Idaho; KXLF-TV, Butte, Montana; KFBB-TV, Great Falls, Montana and KOOK-TV, Billings, Montana. Except for qualifying shares, in the event any Class A stockholder shall sell or otherwise dispose of all or any part of said properties to a person not directly or indirectly related or connected to any other Class A stockholder by stock ownership or other control, and shall, as a condition of such sale desire to sell any or all of his Class A stock in this corporation, the aforesaid restrictions on the sale of said Class A stock shall not be imposed, provided that the purchaser of such stock shall contract to retain the affiliation and relationship with this corporation that have theretofore existed between said television station and this corporation."
