KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned, being a natural person of full age and a citizen of the United States of America, the incorporator, do hereby certify and state as follows:

 $\underline{\text{FIRST}}\colon$ The name of the corporation is MOUNTAINEER LOG HOMES, INC.

SECOND: This corporation is formed and organized to engage in the general business of the manufacture, sale, distribution and installation of log homes, of any kind, or for any other lawful purpose as the Board of Directors may from time to time determine, and shall have all the statutory powers conferred upon corporations by Title 30 of the Idaho Code, as it now exists or as it may from time to time be amended.
