ARTICLES OF INCORPORATION

OF

VALLEY VISTA CARE CORPORATION

The undersigned incorporators, desiring to form a Corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act, adopt the following articles of incorporation:

ARTICLE I

Name. The name of the Corporation is Valley Vista Care Corporation.

ARTICLE II

Purpose. The purpose of the Corporation is to operate and maintain a Christian health care and housing facility for the elderly and infirm in the form of long term nursing home care, shelter care and apartment living. The Corporation has a further purpose to promote any and all other activities which are consistent with the provision of health care and service, and maintenance generally of Christian ministry, and consistent with any other lawful purpose or purposes of the Idaho Nonprofit Corporation Act.

ARTICLE III

Duration. The period of duration of this Corporation is perpetual.

ARTICLE IV

This Corporation is not for profit.

ARTICLE V

Registered Office and Registered Agent. The address of the Corporation's initial registered office in the State of Idaho is 10 Milwaukee Road, City of St. Maries,

County of Benewah, State of Idaho 83861. The name of the Corporation's initial registered agent at such address is Jeanne M. Robinson.

#### ARTICLE VI

The governing and managing authority of the Corporation shall be vested in a group of members, and said members are set forth hereafter. The members of the Corporation which are set forth in this Article shall also be the initial Board of Directors for the Corporation. There shall be six (6) members and directors initially of said Corporation, whose names and addresses are as follows:
