**ARTICLES OF INCORPORATION**

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated pursuant to the laws of the State of Idaho, do hereby certify as follows:

**ARTICLE ONE**

**NAME**

The name of the corporation shall be: AGRICULTURAL BUSINESS AND FINANCIAL SERVICES, INC.

**ARTICLE TWO**

**PURPOSES AND POWERS**

(1) To carry on all or any of the business of advising and consulting individuals and businesses concerning financial and management matters in the agricultural field.

(2) To obtain and/or provide financial services, loans, real estate appraisals and management services to businesses and individuals in the agricultural field.

(3) In connection with the above-mentioned purposes, the corporation shall have the power to invest its' funds in real property and securities, to acquire, own and dispose of real and personal property and to do ALL OTHER ACTS TO THE EXTENT PERMITTED under Chapter 1 of Title 30 of the Idaho Code, and any present and future amendments thereto.

### ARTICLE THREE

The aggregate number of shares of stock that the corporation is authorized to issue is 100,000 shares, which share shall be common stock with no par value.


ARTICLE EIGHT
