#### ARTICLE I.

#### <u>NAME</u>

The name of the Corporation is STRIP AND SELL, INC., which shall be a general business corporation.

#### ARTICLE II.

# PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

#### ARTICLE III.

## **PURPOSES AND POWERS**

- 1. <u>PURPOSES</u>: The purpose of this Corporation is to engage in any lawful business activity.
- 2. To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Idaho.

- 3. To have the capacity to act possessed by natural persons in the performance of such acts as are necessary or proper to accomplish its purposes and which are not repugnant to law.
- 4. Without limiting or enlarging the grant of authority contained in Paragraph 3 of Article III, it is hereby provided that such corporation shall have authority:
  - a. To sue or be sued, appear, complain and defend in any court of law or equity, or before any board, commission or tribunal;
  - To have and use a corporate seal which may be altered at will, and to use
    it, or a facsimile of it, by impressing or affixing it or in any other manner
    reproducing it;
  - c. To make and amend bylaws, not inconsistent with its articles of incorporation or with the laws o this state, for managing the business and regulating the affairs of the corporation;
  - d. To purchase, receive, lease, or otherwise acquire, and own, hold, improve, use, and otherwise deal with real or personal property, or any legal or equitable interest in property wherever located;
  - To sell, convey, mortgage, pledge, lease, exchange, and otherwise dispose
    of all or any part of its property;
  - f. To purchase, receive, subscribe for, or otherwise acquire; own, hold, vote, use, sell, mortgage, lend, pledge, or otherwise dispose of; and deal in and with shares or other interests in, or obligations of, any other entity;

- g. To make contracts and guarantees, incur liabilities, borrow money, issue its notes, bonds, and other obligations, which may be convertible into or include the option to purchase other securities of the corporation, and secure any of its obligations by mortgage or pledge of any of its property, franchises, or income;
- To lend money, invest and reinvest its funds, and receive and hold real and personal property as security for repayment;
- i. To be a promoter, partner, member, associate or manager of any partnership, joint venture, trust or other entity;
- j. To conduct its business, locate offices, and exercise the powers granted by this chapter within or without this state;
- k. To elect directors and appoint officers, employees, and agents of the corporation, define their duties, fix their compensation, and lend them money and credit;
- I. To pay pensions and establish pension plans, pension trusts, profit sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees and agents;
- To make donations for the public welfare or for charitable, scientific, or educational purposes;
- n. To transact any lawful business that will aid governmental policy;

- To make payments or donations, or do any other act, not inconsistent with
  law, that furthers the business and affairs of the corporation.
- 5. The foregoing clauses shall be construed both as Purposes and Powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of the corporation.

#### ARTICLE IV.

#### **BYLAWS**

Provisions for the regulation of internal affairs of the Corporation shall be set forth in the corporation's Bylaws.

#### ARTICLE V.

## DATA RESPECTING SHARES

The aggregate number of shares which the Corporation shall have authority to issue is one hundred (100) shares of common stock at \$1.00 par value per share. Such shares are the only class authorized. Transfer of all such shares are subject to restrictions as set forth in detail in the bylaws of the Corporation; also, a synopsis of such restrictions shall be set forth on the obverse side of all share certificates when and as they are issued.
