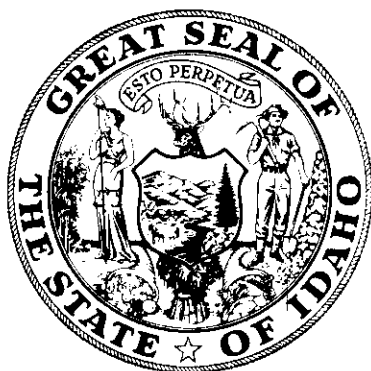

Pursuant to the provisions of section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SCOTWAY PRESS, INC..

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation at the annual meeting of this corporation on February 28, 1985, in the manner prescribed by the Idaho Business Corporation Act.

Article IX of the Articles of Incorporation of SCOTWAY PRESS, INC. is hereby amended by deleting all matters contrary to the below amendment and by the addition of the following amendment, to-wit:

"That from and after March 1, 1985, the Board of Directors of this corporation shall consist of two (2) persons whose terms shall be for a term of one (1) year expiring at the annual meeting of this corporation, which is held on the 4th Thursday of February of each calendar year."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 10,000,000; and the number of shares entitled to vote thereon was 10,000,000.

FOURTH: The number of shares voted for such amendment was 10,000,000; and the number of shares voted against such amendment was none.
