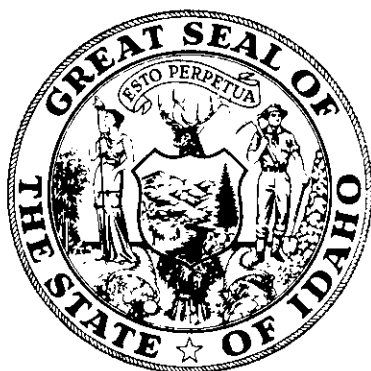

We, the undersigned, Harold M. Abend, and Eileen Abend, as President and Secretary, respectfully, of Nonpareil Corporation, an Idaho Corporation, which has applied for reinstatement of the Secretary of State of Idaho, do hereby certify as follows:

1. The name of the corporation was Nonpareil Corporation.
