ARTICLES OF AMENDMENT

OF

WOODS DISTRIBUTING INC.

(9)

The undersigned, for the purpose of amending the Articles of Incorporation on file with the State of Idaho, hereby state as follows:

- a) The present name of the corporation is WOODS DISTRIBUTING INC.
- b) The directors shareholders and of the corporation have amended Article V of the Articles of Incorporation to provide as follows:

ARTICLE V.

- 1. This corporation is authorized to issue two (2) classes of shares of stock to be designated "CLASS A COMMON" and "CLASS B COMMON".
- 2. The total number shares that this corporation is authorized to issue is 50,000 and the aggregate par value of all such shares is \$50,000.00.
- 3. 16,667 of the shares shall be CLASS A COMMON shares of a par value of ONE DOLLAR (\$1.00) per share.
- 4. 33,333 of the shares shall be CLASS B COMMON shares of a par value of ONE DOLLAR (\$1.00) each.
- 5. The company is permitted to purchase its own stock of either class.

6. The only difference between the CLASS A COMMON stock and the CLASS B COMMON stock shall be in the voting The holders of the CLASS A COMMON and CLASS B COMMON stock shall in all matters vote together as a single class; provided that the holders of the CLASS A COMMON stock shall have three (3) votes for each share and the CLASS B COMMON stock shall have one (1) vote for each share.

- c) The above amendment adopted was bу the shareholders and board of directors on January 8, 1986.
- d) There were 30,000 shares of common stock outstanding which were entitled to vote on said amendment.
- There were 30,000 shares voted in favor of said e) amendment. There were no shares voted against said amendment.
