No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision in these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt under Section 501(c)(3) or a corporation, contributions to which are deductible under section 170(c)(2) of the IRC.
