We the undersigned, incorporator(s), hereby associate ourselves together to form and establish a corporation FOR profit under the laws of the State of Idaho.

Article 1: Name of corporation is MICROWAREHOUSE, LTD.

Article 2: The period of duration of this corporation shall be PERPETUAL.

Article 3: This corporation shall be organized for the purpose or purposes, or to include, the transaction of any or all lawful business to be conducted or promoted as follows;

The corporation will engage in the production, marketing, distributing, buying and selling of computer software, hardware and any other related products. In addition, the corporation shall engage in offering workshops, act as a consulting firm and act as a publisher.
