



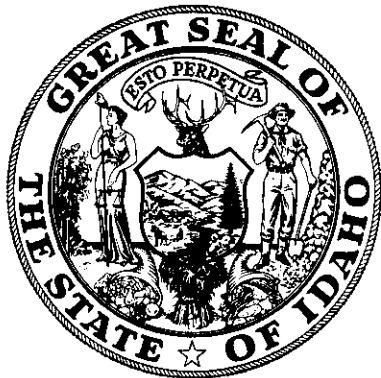
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned, acting as the incorporators of a corporation organized under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of this corporation is McCAD SYSTEMS, INC.

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The purpose or purposes for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock with a par value of \$1.00 each.

ARTICLE V.


