ARTICLES OF INCORPORATION

OF

TRACTOR SALES & AUTO, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all of whom are residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

I.

That the name of this corporation shall be TRACTOR SALES & AUTO, INC.

II.

That the purposes for which it is formed are:

- To engage in the sale of tractors, farm implements, automobiles, repairs, parts and accessories for same and to engage in and to carry on within and without the State of Idaho, a general retail and wholesale business in tractors, farm implements, automobiles, motor trucks and other mechanical propelled, or motor or power driven vehicles, to acquire, buy, sell, trade, vend, distribute, store, care for and keep for hire, repair, service, and deal in new and used farm implements, tractors, automobiles, motor trucks, motor cars and mechanically propelled or motor or power driven vehicles and conveyances, tractors, farm and other types of implements, machinery, equipment, appliances, and tools of every kind, nature, or discription, accessories, equipment, appliances, parts, tires, hardware, petroleum products and any and all other articles and merchandise necessary or incidental to the operation, servicing, repairing or pertaining to the things and matters herein enumerated.
- (b) To carry on and engage in within and without the State of Idaho a general machine shop, garage, and storage business, and to repair tractors, trucks, motor cars, automobiles and other

mechanically propelled or motor.or power driven vehicles, farm machinery and conveyances and farm and other kinds of implements and machinery.

- (c) To act as agent for any manufacturer or distributor of tractors, motor trucks, motor cars, automobiles and other mechanically propelled or motor or power driven vehicles and conveyances farm and other kinds of implements and machinery, accessories or any or all of the items, matters, or things named in these articles and to enter into agreements with any of such manufacturers or distributors relative to any such agency or agencies.
- (d) To obtain, acquire, hold, possess, and own patents of any and all kinds of machinery or improvements thereon, or articles of any nature.
- (e) To borrow money and to issue bonds debentures and other obligations of the dorporation and to mortgage or pledge its property, as security for borrowed money or other obligations.
- (f) To receive, acquire, hold, purchase, sell, dispose of, convey, mortgage, and/or lease real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, frachises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge, and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.
- (g) To have all the powers and authority provided and authorized by the laws of the State of Idaho for corporations, and to have and perform any and all of the said powers and matters within or without the State of Idaho.
- (h) To do each and everything necessary, suitable or profitable for the accomplishment of any of the purposes and objects herein enumerated, or which shall at any time appear conducive to or expedient for the benefit of this corporation.

III.

That the location of and post office address of its registered office in the State of Idaho is the City of Idaho Falls, County of Bonneville, State of Idaho.

IV.

That the term for which it is to exist is fifty (50) years from and after the date of its incorporation.

V.

That the capital stock of this corporation shall be Fifty Thousand and No/100 (\$50,000.00) Dollars, divided into five hundred (500) shares of the par value of One Hundred and No/100 (\$100.00) Dollars per share.
