PIONEER REVIVAL CENTER OF IDAHO, INC.

was filed in the office of the Secretary of State on the **Thirtieth** day of **August**, A. D. One Thousand Nine Hundred **Sixty-one** and is duly recorded on Film No. 114 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Pifty years** from the date hereof, with its registered office in this State located at **Declo** in the County of **Cassia**

and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION PIONEER REVIVAL CENTER OF IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, /citizens of the United
States of America, and residents of the County of Cassia,
State of Idaho, under and by virtue of the provisions of the
statutes of the State of Idaho, do hereby incorporate ourselves
into a voluntary association for the purposes of forming a
private, nonprofit corporation under such laws and upon the
following terms and conditions.

ARTICLE I.

The name of the corporation shall be PIONEER REVIVAL CENTER OF IDAHO, INC.

ARTICLE IT.

The purpose for which the corporation is formed is to transact business in the name of the corporation in accordance with the statutes of the State of Idaho relating to Religious Corporations; to further the teachings of the gospel as contained in the Old and New Testaments; to conduct schools and classes for teaching and to teach the Bible and Bible truths; to buy, sell, or give away, and otherwise distribute Bibles and other liturature concerning and containing information and comment explaining the Bible and prophesy contained thereon; to hold title to real property, and to construct and erect

poration. That on the 12th day of October, 1960, three Trustees were elected at a meeting held at the regular meeting place in Declo, Cassia County, Idaho, pursuant to notice of the time, place and purpose of said meeting having been duly and legally published in the "Burley Herald Bulletin", a newspaper regularly printed and published in Cassia County, State of Idaho, and of general circulation in Cassia County, Idaho, the paper most likely to give notice to the members of said meeting and election, and a like notice was posted on the building at which meeting and election was noticed to be held, in a conspicious place for the same length of time that it was published, to-wit: for a period of Two (2) weeks immediately proceeding such meeting and election; that at such meeting a majority of the members of the Declo Church ware present and voted in such election of Trustees hereinafter named, and on all other questions relating to the organization of said corporation as wholly appears in the verified certificate of the officers who conducted said meeting and election hereunto annexed and made apart of these articles as though separately and severally set out herein. That Arthur Schiewe, Waymon D. Yarbrough and Carl Engbloom were the duly elected Trustees. The Trustees were elected for the purposes of management of the real estate of the corporation. ARTICLE VI.

That the corporation shall have a Board of Directors for the promotion, operation and maintenance of the corporation consisting of Five (5) duly elected persons. That on the 12th

buildings and facilities thereon for the purpose of carrying out the general purposes of the corporation, to pledge or mortgage the real or personal property of the corporation for the purpose or procuring money or property to use for the furtherance or purposes of the corporation; to take, receive, hold and disburse donations and contributions of money and property, bequests and legatees to further the purposes of the corporation, which purposes are wholly benevolent, charitable, educational, christian, and philanthropic, and not in any sense for profit; to own and operate a printing press to print its own liturature, books, papers, or other papers used by the corporation in carrying out religious purposes; to do such other things as may from time to time be allowed by law now existing or which may hereafter exist in carrying out the purposes of the corporation.

ARTICLE III.

The principal office and domicile of the corporation shall be Declo, Cassia County, Idaho, and any other place as it may become necessary.

ARTICLE TV.

The Corporation shall exist for a period of fifty (50) years.

ARTICLE V.

The Corporation shall have a Board of Trustees consisting of three (3) duly qualified and elected persons, whose terms of office shall be set forth in the By=laws of the Cor-

MINUTES OF THE FIRST MEETING OF INCORPORATORS OF THE PIONEER REVIVAL CENTER OF IDAHO

The first meeting of incorporators of the Pioneer Revival Center of Idaho, was held at the regular meeting place of said organization in Declo, County of Cassia, State of Idaho, on the 12th day of October, 1960, at 8:00 o'clock P.M., a majority of said organization being present.

John Lee Spivey, acted as Chairman of the meeting and presided over the deliberations as chairman. At the request of the chairman, Lile Opal Spivey, acted as Secretary of the meeting and recorded the proceedings.

Upon motion duly made, seconded and unanimously carried it was

RESOLVED: That a corporation be organized and incorporated under the laws of the State of Idaho relative to religious nonprofit corporations and that it be known as the Pioneer Revival Center of Idaho, and that John Lee Spivey, Waymon D. Yarbrough and Lily Opal Spivey be responsible for and file the required Articles of Incorporation; that a board of five (5) directors be elected to be responsible for the promotion, operation and maintenance of the corporation, and that a board of three (3) trustees be elected for the management of the real estate of said corporation.

The chairman then called for nominations for directors of the corporation and the following persons were duly elected:

The chairman then called for nominations for trustees and the following persons were duly elected trustees of the corporation:

Thereupon, upon motion duly made, seconded and unamiously carried, the meeting was adjourned.
