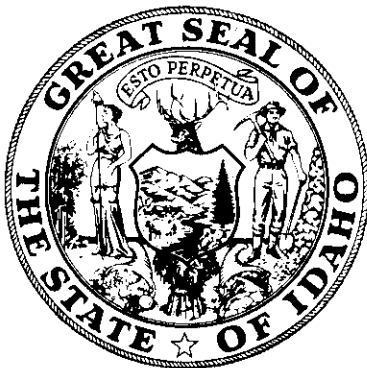

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,
being persons of full age and being citizens of the United
States, in order to form a corporation for the purposes
hereinafter stated, pursuant to the Business Corporation Act of
Idaho, do hereby certify as follows:

FIRST: The name of the corporation is RED CEDAR PRODUCTS,
INC.

SECOND: The purposes for which said corporation is formed
are: to buy and sell cedar shakes and other building materials
and any other lawful purpose.

THIRD: The corporation is to have perpetual existence.

FOURTH: The location and address of the registered office

and the name of its initial registered agent at such address

FIFTH: The total authorized number of shares which the
corporation shall have authority to issue is 10,000 shares, all

successors are elected and shall qualify are:



