ARTICLES OF INCORPORATION  
OF

The undersigned, CONNIE VANGUNDY, being qualified as an incorporator of a corporation under the Idaho Business Corporate Act, of legal age, enters into these Articles for the purpose of forming a corporation under the laws of the State of Idaho, and does hereby make, adopt, execute, and acknowledge these Articles of Incorporation as follows:

ARTICLE I: Corporate Name

The name of the corporation shall be FLOTEE INVESTMENTS, INC.

ARTICLE II: Shares

The corporation shall have authority to issue 500,000 shares of common voting stock.

ARTICLE III: Initial Registered Office and Registered Agent

The initial registered office of the corporation shall be located at 200 Eagleview Lane, Sandpoint, Idaho 83864. The initial registered agent at the address shall be CONNIE VANGUNDY.

ARTICLE IV: Initial Board of Directors

The number of directors of this corporation shall be not less than one nor more than nine. RON VANGUNDY shall serve as the Board of Directors until the first annual meeting of shareholders or until the successor(s) has been elected and qualified. RON VANGUNDY shall be the initial chairperson of the Board of Directors.
