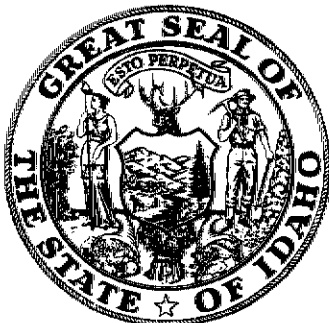

KNOW ALL MEN BY THESE PRESENTS:

1. That the name of the corporation is **MOBILE SOURCE, INC.** of 3477 Sun Circle, Idaho Falls, Idaho 83404, but that the name of the corporation as amended will be **COMMTec CORPORATION.**

2. That at a meeting of the members of the **MOBILE SOURCE, INC.** (hereinafter "Corporation"), duly called by notice, said notice setting forth the specific purpose of amending the Articles of Incorporation of the Corporation, was held at 1875 Fourth Avenue East, Twin Falls, Idaho 83301, on June 11, 1996.

3. That at said meeting of the members of the Corporation, a quorum being present, the following amendments to the Articles of Incorporation of the Corporation were duly proposed and adopted by the members with the majority of the members entitled to vote thereon voting for said amendments, either in person or by proxy. The number of members entitled to vote on said amendments was one (1), with one (1) members voting for and no members voting against the proposed amendments.

**RESTATED**  
**ARTICLES OF INCORPORATION**  
**OF**  
**COMMTEC CORPORATION**

The undersigned, acting as the director of a corporation under the Idaho Business Corporation Act, adopts the following Restated Articles of Incorporation for such corporation, except for the designated amendment the Restated Articles of Incorporation correctly sets forth without change the corresponding provisions of the Articles of Incorporation as theretofore amended, and that the Restated Articles of Incorporation together with the designated amendment supersede the original Articles of Incorporation and all amendments thereto:

*FIRST:* The name of the corporation is changed and amended to **CommTec Corporation**.

*SECOND:* The period of its duration is perpetual.

*THIRD:* The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

*FOURTH:* The corporation shall have authority to issue 10,000 shares of common stock, all of one class, with no par value.

*FIFTH:* The address of the corporation's initial registered office is 3477 Sun Circle, Idaho Falls, ID 83404, and the name of its initial registered agent at that address is John Jay Kindred.

*SIXTH:* The number of directors constituting its initial board of directors is one, whose name and address is:
