## ARTICLES OF INCORPORATION

OF

HALLMARK MANUFACTURING COMPANY, INC.

I, the undersigned, a natural person of the age of twenty one years or more, acting as incorporator under the Oregon Business Corporation Act, adopt the following Articles of Incorporation.

#### ARTICLE I.

The name of this Corporation is HALLMARK MANUFACTUR-ING COMPANY, INC., and its duration is perpetual.

## ARTICLE II.

The purpose for which the corporation is organized is to manufacture, buy, sell, distribute and deal in women's and girls' wearing apparel.

## ARTICLE III.

The aggregate number of shares which the corporation shall have authority to issue is Five Hundred (500) shares, without par value.

## ARTICLE IV.

The corporation will not commence business until consideration of the value of One Thousand (\$1,000.00) Dollars or more has been received by it for the issuance of its shares.

## ARTICLE V.
